Probable Cause

The following incident was being investigated by the Gainesville Police Department. Throughout the course of the investigation, it was determined that the incident took place at 7801 SW 56th Avenue, which is a residence within the unincorporated area of Alachua County. The Gainesville Police Department contacted the Alachua County Sheriff's Office, based upon jurisdictional boundaries, and provided the following facts:

On 10/19/23 at approx. 1400 hours, Daniel Dominguez posted a video on his social media (Instagram) account of him disclosing that he plans on shooting up a middle school (in Alachua County) on Saturday or Sunday. Dominguez was sitting in front of a book shelf with an AR15 rifle on his right side and a black handgun to his left side. Dominguez stated that he did not want to hurt anyone and just shoot at the school with the hope the police will respond and kill him. Dominguez then left several disclaimers attached to the video advising that "this is an Art piece".

FDLE contacted GPD Lt. Lugo in reference to an analyst discovering this video. GPD officers were able to identify Dominguez (he provided his name in the video) and saw that he previously lived near Parker Elementary (1912 NW 5th Ave). It was believed that the school or a nearby school may have been his target. The information was then forwarded to GPD Patrol Operations. Lt. Lugo approved for dispatch to request a ping on Dominguez's cell phone. Dominguez was eventually found in the area of Satchel's Pizza, located at 1800 NE 23rd Avenue, where he was apprehended without incident.

While being transported to the GPD station, Dominguez made an excited utterance advising that his guns were in his bedroom at his dad's house (7801 SW 56th Ave, Gainesville, FL). GPD Det. Dose sat down with Dominguez in a GPD interview room, where he was asked if he knew why he was here. Dominguez advised it was because of his video. Post Miranda, Dominguez stated that he wanted a lawyer.

At the time the information was provided to GPD, it was believed the target was within the city limits of Gainesville. GPD patrol and ASO patrol responded to 7801 SW 56th Avenue, where contact was made with both of Dominguez' parents. After conducting a safety sweep of the residence, it was determined the video was filmed in the residence, which is within the unincorporated area of Alachua County. An AR15 style weapon, which appeared to be similar to that depicted in the video, was observed within plain view of the law enforcement officers conducting the protective sweep. The residence was secured and ASO Detectives were summoned to respond.

Based upon the discovery that this incident fell outside of the jurisdictional limits of the Gainesville Police Department, Dominguez was turned over to the custody of deputies with the Alachua County Sheriff's Office.

Due to Dominguez's statement of "I have decided to take up arms, and attack the state. I intend to target a middle school, particularly the middle school I went to" and "I will be going on a Saturday or a Sunday when no children are there with the intention of getting off as many Nato .556 rounds from my AR15 at the building" while holding the rifle, Dominguez committed an act of terrorism or conspired in terrorist activity.

Dominguez is being charged with 1 count of FSS 836.10 - Written or electronic threats to kill, do bodily injury, or conduct a mass shooting or an act of terrorism and 1 count of FSS 775.30 - Terrorism.

Dominguez was arrested and transported to the ASO DOJ without incident.


