**Probable Cause**

On 10/3/2023 at approximately 1750 hours the Alachua County Sheriff's Office (ACSO) was dispatched to the intersection of NW 76<sup>th</sup> Blvd and W Newberry Road in regards to an armed disturbance.

The caller, BRODERICK CRAWFORD (7/25/1990 B/M) contacted ACSO after he was threatened with a gun at the intersection by a passing motorist. Rodderick provided a vehicle description of a white Ford truck with a topper and the white male driver was armed with a revolver. He later stated that the Ford truck had an attached FL tag of KSHN21 and it was last seen pulling into Taco Bell.

I arrived on scene and the call was being processed through ACSO and located the above truck at Taco Bell. I was operating a fully marked ACSO patrol vehicle which is clearly marked as such, furthermore I was wearing the standard issued uniform of the day. I parked in front of the truck with my emergency lights activated. I ordered the white male driver who was wearing a blue shirt out of the truck at gun point. He looked at me, put his truck in drive and attempted to drive around my vehicle. Once he had no where to go because the drive thru line was full he put his truck in park. The driver was once again ordered out of the truck, where he grabbed his handgun in his right hand. He then threw the gun in the backseat and refused further commands. He was eventually detained in handcuffs and identified as VIRLEN JAKCSON (9/16/1957 W/M).

ACSO deputies contacted Rodderick who advised that he wanted to pursue criminal charges, furthermore he had his small children in the car at the time of this incident. Rodderick stated that the white male driver pointed the gun at them while leaving the bank of America parking lot.

ACSO deputies retrieved the handgun from the Ford F-150 which was identified as a Dan Wesson Revolver (.357 magnum), the Revolver was loaded with six rounds of ammunition.

ACSO deputies conducted a show up with Rodderick. He positively identified Virlen as the male who pointed the gun at him.

Virlen was placed under arrest for Resisting without violence (FSS 843.02) and aggravated assault with a deadly weapon without intent to kill (FSS 784.021.1A)
