PROSECUTIVE SUMMARY - CONTINUED

Instead DEF pulled out a pocket knife and stabbed VIC once in the abdomen.

VIC stated once DEF stabbed him, DEF stated "that`s a death wish".
VIC advised he then hurried back to his vehicle until LEO and EMS arrived on scene.

DEF was located and detained approximately 3 blocks away from the LOI (4300 Newberry Rd).

Upon being detained the DEF made the spontaneous statement "I Have the right to defend myself". A blue and black colored knife was located at the location the DEF was detained.

The DEF was identified via RMS search.
