**MOTION FOR PRETRIAL DETENTION**

COMES NOW the State of Florida, by and through the undersigned Assistant State Attorney, and moves this honorable court to enter an Order detaining the Defendant in custody pending a final hearing on Pretrial Detention, and sets forth with particularly the grounds and essential facts, as follows:


1. The Defendant has been arrested for an offense for which detention may be ordered under §907.041, Fla. Stat., to wit: Burglary with assault or battery as well as aggravated abuse of a child.
2. The State will show that there is a substantial probability that the defendant poses the threat of harm to the community. The defendant is presently charged with a dangerous crime, there is a substantial probability that the defendant committed such crime, the factual circumstances of the crime indicate a disregard for the safety of the community, and there are no conditions of release reasonably sufficient to protect the community from the risk of physical harm to persons.
3. The grounds for seeking pretrial detention, as well as essential facts alleged, are contained the sworn affidavit by Deputy William Baker, and is attached hereto and incorporated as Exhibit A.

WHEREFORE, the State respectfully moves this honorable court to find that there is probable cause to believe that the Defendant committed the offense, and that the Defendant should be detained in custody pending a final hearing on Pretrial Detention.

Probable Cause

This Probable Cause Narrative was authored by Detective J. Barlow I.D. # 0944:

The Defendant, Douglas Strain, did, willfully and intentionally, commit the acts of Burglary with battery (F.S. 810.02.2a), Criminal Mischief during the commission of a burglary (F.S. 806.13.1b2), Felony Battery (F.S. 784.041.1), Hindering use of 911 (F.S. 914.22.1e), False Imprisonment of a person (F.S. 787.02.2), Fleeing and Alluding (F.S. 316.1935.3a), and Aggravated Child Abuse (F.S. 827.03.2a).

On 4/10/2024, the Defendant, Douglas Strain, arrived at  SW  th St.  (Asbury Park Apartments.

This apartment belongs to [REDACTED] (Victim 1) who is the Defendant's mother. The Defendant and Victim 1 have been having domestic issues between each other which has led to Victim 1 requesting the Defendant to leave and move out. The Defendant has since moved out of this residence.

On today's date, the Defendant attempted to return to the address and was denied entry by Victim 1 at the front door. The Defendant then proceeded to the rear of the residence and forcefully gained entry through the back door by breaking the glass window inside the door. The Defendant then entered the residence while Victim 1 attempted to contact the ACSO CCC via cellphone. The Defendant then took Victim 1 cellphone from her person preventing her from contacting the ACSO CCC for help. The Defendant then threw Victim 1 to the ground and began battering her with a closed fist several times upon the face. The actions of the Defendant caused Victim 1 to lose consciousness. The Defendant's actions caused Victim 1 to suffer severe facial swelling over her left eye and the right side of her forehead. Victim 1 was also observed vomiting several times while on scene with deputies due to being dizzy at the time.

The defendant then exited the residence and instructed his younger brother, [REDACTED] (Victim 2) to get in the vehicle with him. Victim 2 did as he was instructed, and the Defendant fled the area. Deputies responding to the incident location spotted the vehicle driven by the Defendant and attempted to conduct a traffic stop. The Defendant did not obey with the traffic stop and fled from deputies while placing the general public and Victim 2 in danger. During this pursuit, Victim 2 told the Defendant that patrol deputies were behind him to which the Defendant said he was trying to keep him safe. The Defendant eventually lose control of the vehicle and crashed. Deputies were able to place the Defendant in custody and provide medical aid to Victim 2.

The Defendant was interviewed post Miranda. During the interview, the Defendant provided details that were inconsistent with the evidence presented on scene and witness statements. When challenged about his statements, the Defendant requested a lawyer present and the interview stopped.

The Defendant was placed under arrest and transported the ACSO DOJ after being medically cleared.
