the argument she observed the DEF poke the VIC in the face multiple times. The WIT stated after she saw the DEF poke the VIC, she and two other security officers went to the parking garage to separate the two. The WIT provided me with the security footage of the incident.
After I watched the surveillance footage that the WIT provided me, I observed the DEF and VIC arguing as they walked to the VIC's car. The surveillance footage showed while they were in the car together, the DEF poked the VIC's face multiple times. The surveillance footage showed after the DEF poked the VIC the first time, the VIC attempted to swat down the DEF's hands; however, the DEF continued to poke the VIC in the face.
The DEF and the VIC are involved in an ongoing 12 moth dating relationship; however, they are not intimate.
The WIT positively identified the DEF when I arrived because he was sitting across the street with the VIC.
