PROBABLE CAUSE

On 11/6/2020, I attempted to conduct a traffic stop on a red Mini motorcycle that was riding in the roadway without a license plate, was riding on the side walk, did not have brake lights, did not have turn signals, and failed to use signals multiple times.

Upon activating my emergency lights and sirens at approximately 300 NE 10th AV the motorcycle slowed down and turned around. The driver of the vehicle who was later identified as Rodricas Young then drove towards me and told me his brakes didn't work well and it was hard for him to stop. Rodricas was driving towards me at approximately 5 MPH at this time. As Rodricas drove towards me he then accelerated away at a high rate of speed traveling away from my patrol vehicle. I then turned my patrol vehicle around to follow and Rodricas turned around once again and began driving the opposite direction. Rodricas was looking back at me and was fully aware I was attempting to stop him while my lights and sirens were activated.

Rodricas ultimately drove his vehicle into a dead end and ditched his motorcycle. Rodricas then jumped a fence and fled on foot into a patch of woods on the East side of Waldo Rd.

A perimeter was then set up and a K-9 track was conducted. The K-9 ultimately tracked to a tent in the woods where Rodricas was located. Upon making contact with Rodricas at the tent he gave law enforcement the name of Michael T Jones, provided the birthday of 8/4/80, and the social security number of [REDACTED]

I identified Rodricas as the subject that fled the scene. Rodricas additionally admitted that he was the subject that fled the scene and identified himself by his true name. Post Miranda Rodricas admitted that he fled on the motorcycle because he had marijuana and was scared. Rodricas stated that he then changed clothing and hid in the tent.

Subsequently Rodricas is being charged with Fleeing and eluding, false information to LEO, and Resisting without violence.
