arm fully extended in front of him as gunshots continued to run out. It appeared like the DEF had a handgun in his hand and was chasing after an unknown person shooting at them. As the DEF ran through the breezeway I lost sight of him. Shortly later I observed a vehicle leaving the area of the apartment complex where the shooting occurred at a high rate of speed. I notified marked officers who conducted a traffic stop on the vehicle. The vehicle initially did not stop but eventually came to a stop approximately 4 blocks later. The DEF (front seat passenger) immediately ran from the vehicle. Officers told him to stop and he ignored their commands and continued to run. A perimeter was established and eventually the DEF was taken into custody after a K-9 tracked to him.

Post Miranda, the DEF stated that the vehicle picked him up at a gas station and he was never in Woodland Park Apartments. I know this to be a lie because I observed the vehicle inside of the complex leaving the scene of the shooting just prior to the traffic stop. The DEF stated that he ran from the vehicle and officers because he knew that he had outstanding warrants.

On scene of the shooting officers located one shell casing on the first floor breezeway of the building I observed the DEF running from. Additionally, officers located an impact and a projectile in the wall of the building to the west. This apartment complex building is occupied by several residents who were home at the time of the shooting. A presumptive gunshot residue kit was completed on the DEF which was positive for GSR.

The DEF is a multi-time convicted felon, specifically a convicted felon out of Alachua County for homicide see court case number 012002CF001083XXXXXX. The DEF was in actual
