not know the defendant and has never given him permission to be in the business.

A walk through of the business revealed that there were multiple missing power tools and air conditioning units. The total number and value of the items are pending inventory and serial number retrieval.

The business also had multiple windows from frames stored inside the business broken. There were also multiple cans of paint that were opened and paint thrown on multiple surfaces including, floors, walls, and loose items such as tools, wooden items, and other loose items in the area. The total estimated damage as of this writing is \$1500.

Post Miranda the defendant stated he was lead to the property by someone on 5-2-24 at approx. 0800hrs. He was unable to state who this person was or provide any type of description of this person. He entered onto an adjacent piece of property south of the above business. From there he climbed between another fence and tree to gain access to the property. He noted the front door was locked so he walked around the business to find any open doors there may have been. The defendant had to climb another fence that led to the rear of the property where he located an open door and entered the closed business.

Once inside the defendant stated he located the room where he was located and it was full of multiple A/C Units. He removed all but one of the units and used it to keep the room cool. When asked what he did with the rest of the A/C units, he replied "what A/C units?"

PROSECUTIVE SUMMARY - CONTINUED
The defendant stated he took the paint and used it to create "splatter art" inside the business. The defendant stacked multiple items on a work bench and mobile tool box and his splatter art was applied to these items as well.
He stated he had no knowledge of the missing tools but did state he would have used any of the tools while inside but would not have taken them away from the business. Lastly he stated all the broken glass was already there when he got there. He remembers hearing glass break while he was creating his splatter art and stated the broken glass noise was coming from a nearby glass factory. There are no such businesses in the area.
The defendant was covered in paint and also had minor lacerations on hands which appear to be consistent with exposure to broken glass from the window panes.
