On 2-20-23 at approximately 2028hrs, officers responded to Walgreens (5171 NW 43rd St) in reference to an armed robbery. Upon arrival officers learned that a black male wearing an orange hoodie, face mask and black pants entered the store and went directly to the pharmacy section of the business. The suspect then jumped over the counter and into the pharmacy area which an employee was working and had access to numerous prescription medications (filled in patient pharmacy bottles and pharmaceutical bottle specific to the medications). The suspect demanded to the employee, "I have a gun, give me all the percocets." The suspect also repeated to the employee to not look at his

face. The suspect produced a backpack that had previously been underneath his hoodie. The employee was unable to access the locked safe to access percocets due to a timed entry and then the safe jammed. The suspect ultimately took cash from the drive thru cash till (approx. \$117.03) and primarily cough syrups (promethazine). It is currently unknown the exact types/amounts of any other medications which were taken. The suspect then exited the pharmacy door and left the store via the front entry/exit, just as he entered.

Officers were made aware that there has been a recent string of armed robberies of pharmacies in the general area; High Springs PD jurisdiction and Alachua Co Sheriff Jurisdiction, Clay Co Sheriff's Office jurisdiction. The suspect had a similar MO of going to the pharmacy section then jumping the counter. He also has said to not look at his face and to give him the percocets. The suspect also has worn a hoodie shirt, face mask and carried a backpack. These are all similar to that of this particularly robbery. ASO deputies advised that if this is similar MO/suspects, that the suspect vehicle is a white four door car.

During the Robbery that took place on February 4, 2023 in Keystone Heights the detectives were able to identify the vehicle used during the robbery as a white four door car. The description of the suspect's vehicle was disseminated to law enforcement. After this robbery K9 Cpl. Walsh arrived in the area and began to search for any suspicious white four door cars. Walsh observed a white Hyundai on NW 34th Bvd and NW53rd Ave approximately 4 minutes away from the robbery that just occurred. Walsh attempted a traffic stop on the vehicle and it immediately turned into the parking lot of Home Depot, 5150 NW 13th St. The passenger of the white Hyundai ran from the

vehicle. The passenger was wearing an orange hoodie and carrying a backpack. GPD Ofc. Henderson was in the area and gave chase on foot. During the foot chase Ofc. Henderson was able to see the side of the suspect's face and recognized him as it resembling the DEF. This was based on the DEF and Ofc. Henderson attending high school together. The white vehicle drove a short distance away. The vehicle was found abandoned near the Subway in the same parking lot. During a K9 track, Cpl. Walsh and K9 Stern located a discarded backpack and orange hoodie along the flight path of the passenger who ran.

I compared body camera footage of the foot chase to the surveillance video from Walgreens. The suspect who fled from Ofc. Henderson and Cpl. Walsh was wearing the same clothing as the suspect in the surveillance video of the robbery (orange hoodie, black pants with a white stripes down the legs, dark colored backpack).

The vehicle was towed to Elite Towing and placed in secure storage. On 2-23-23 I obtained a search warrant for the vehicle that the suspect fled from. The search warrant was signed by the Honorable Judge William E. Davis and served on the same day. GPD FCU processed the vehicle and located a pair of black gloves with 2 gray stripes around the wrists on the front, passenger floorboard. These gloves were partially turned inside-out as if they were recently taken off quickly. In the surveillance video of the robbery the suspect is wearing the same style black gloves with 2 gray stripes around the wrists. GPD FCU collected multiple Latent prints from the vehicle including prints from the outer portion of the front, passenger door, which is where the suspect fled from the vehicle. The prints from the passenger door were processed and identified as belonging to the DEF.

Also located on the front, passenger floorboard of the vehicle was a pair of black slides (sandals) and a Dollar General bag containing a pack of Jolly Ranchers and a bottle of Schweppes Ginger Ale. It appeared these items were recently purchased as they were unopened. I learned the most recent hit for the suspect's vehicle's license plate in the FLOCK camera system prior to the robbery was on 2-20-23 at 1925 hours, nearly 1 hour before the robbery. This FLOCK camera showed the suspect's vehicle at the intersection of SW 34th St and SW 35th Pl. Detectives from the Alachua County Sheriff's Office assisted with canvassing Dollar General store purchases of Jolly Ranchers and Schweppes Ginger Ale near the FLOCK camera. It was discovered that a customer purchased a bag of Jolly Ranchers and a Schweppes Ginger Ale on 2-20-23 at 1951 hours at the Dollar General located at 4133 SW 34th St. I obtained surveillance video from ASO Det. Thompson which showed that the customer purchasing these items resembled the DEF (height, build, skin tone, hair style). The customer left the store in a white four door vehicle. The customer was wearing the same style black pants with white stripes as the suspect who fled from K9 Cpl. Walsh and Ofc. Henderson. The customer was also wearing the same style slides located on the front, passenger floorboard.
On 3-6-23 I obtained a search warrant for the backpack located on the K9 track. The search warrant was signed by the Honorable Judge William E. Davis and served on the same day. Inside the backpack was \$116 in cash (denominations of \$1, \$5, and \$10 bills), a partial bottle of Promethazine with Dextromethorphan (DM), a full bottle of Promethazine Hydrochloride 6.25mg/5ml, a partial bottle of Promethazine Hydrochloride 6.25mg/5ml, and a partial bottle of Prednisolone.

PROSECUTIVE SUMMARY CONTINUED

On 3-7-23 the DEF was taken into custody in reference to this case. Post Miranda the DEF identified himself as the person in Dollar General buying the drink and Jolly Ranchers that were left in the vehicle. The DEF said on 2-20-23 he got a ride to the Dollar General from a friend. The DEF said his friend was driving a white four door vehicle. The DEF said after leaving Dollar General and he was dropped off at 3700 SW 27th St (Lexington Crossing) to play basketball. The DEF said he changed into shorts and left the black pants with white stripes inside the vehicle. The DEF also said he left his black slides in the vehicle.

The DEF said he had a previous relationship with the registered owner of the vehicle that was left at Home Depot and he believes that was the same vehicle his friend was driving when they went to Dollar General.

The DEF denied having any knowledge of the robbery and any involvement in the robbery.

The Promethazine with Dextromethorphan and Promethazine Hydrochloride are both a schedule V controlled substance.

This armed robbery is very similar in MO/suspect actions, clothing, words spoken to several other robberies of pharmacies in the area dating back to the beginning of 2023. Pharmacy locations which have been robbed are:
