Upon arrival, they located the Vic inside of the residence with a single gunshot wound to his chest. LEO attended to the Vic who was transported to Shands ER where he received life saving medical care. LEO was informed that the bullet penetrated the Vic's chest and left lung. A portion of the bullet exited the Vic's back and the remainder of the bullet is still inside of the Vic's chest cavity. The Vic has remained at the hospital receiving medical care.

PROSECUTIVE SUMMARY - CONTINUED
While on scene, LEO spoke with Wit1 who stated the following:

On 4/28/24, she was at the aforementioned residence in Pineridge where the shooting occurred. Shortly before the shooting occurred, the Vic had brought food over to the residence which another person was cooking for everyone. The Def was inside of the residence at the time. The Vic left but later returned and was standing outside speaking with her. The Vic entered the residence and the Def asked the Vic to leave because the Vic had stolen items from the Def the prior night. She did not witness the shooting because she went to the other side of the residence away from the front door. She could hear the Def and Vic who were now outside of the residence. She heard the Def tell the Vic "don't walk up on me". She heard one gunshot. The Vic then came through her interior bedroom door on the side of the residence and collapsed on the ground in the corner of the room.

LEO spoke with Wit2 who stated the following:

She was inside of the residence where the shooting occurred. She was in the kitchen cooking food that the Vic had brought to the residence. There was another person (barber) cutting someone's hair in the kitchen while she was cooking. The Vic entered the residence and started to antagonize the barber saying he stole the barber's stuff the other day. The barber and the Vic went outside. She then heard a single gunshot outside the apartment. The Vic then came back inside of the apartment and the barber did not return.

LEO located one single spent FC 9mm shell casing outside of the residence approximately

15 feet from the front door. LEO located barber hair cutting equipment in the kitchen, a gun case for a 9mm pistol firearm, and multiple rounds of FC 9mm ammunition all commingled together. There was a blood trail located along the front door leading down the main hallway to the back bedroom.

With positively identified the Def via his RMS photo. LEO confirmed the Def is known by the alias of "19".

On 4/29/24, LEO spoke with the Vic at Shands ER and he stated the following:

He went to the residence on 4/28/24 and brought food with him. He has had prior issues with "19" in the past. "19" was at the residence cutting a young persons hair. He began to argue with "19" inside the residence. He asked "19" to shake hands in order to defuse the situation. "19" refused to shake his hand so he asked "19" to go outside so he could "beat your ass" as a joke. They both walked outside of the residence. When he got outside, he had his back turned to "19". He turned around and "19" stated "wassup, you ready" and then shot him in the chest with a black and gray firearm. He ran inside of the residence and does not know where "19" went. He did not have a weapon on him at any time.

On 4/29/24, the Def contacted LEO and requested to be picked up in Pineridge. LEO responded to the residence where the incident occurred and then transported the Def to GPD. I spoke with the Def and post Miranda, the Def stated the following:

He cuts hair at the residence and on 4/28/24 was cutting a young persons hair in the

kitchen. The Vic entered the residence and began they got into an altercation. He asked the Vic to leave and the Vic stated "you want me to do you here or outside". He armed himself with a 9mm black pistol firearm in his right hand. The Vic walked outside and he followed the Vic outside with the firearm. They were just outside of the front door and were standing about 10 to 15 feet apart. He does not recall if the Vic had anything in his hands. He gave the Vic a warning to stay back. The Vic proceeded towards him, he took a step back, and then fired one single shot at the Vic with his firearm. The Vic then fled inside of the residence. The Def stayed on scene for some time but later left. The Def discarded the firearm in a lake and would not tell LEO where.
