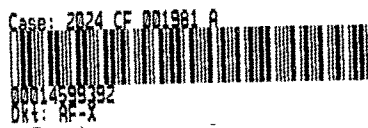

Probable Cause

On June 2nd, 2024, at approximately 17:10 hours, I responded to 3984 SW 43rd Street, Texas Roadhouse Restaurant, regarding criminal mischief.

Investigation revealed that on the above date at approximately 14:47 hours, the defendant, Gina Maria Musolino, a white female, DOB 3/20/1964 committed the crime of felony criminal mischief and misdemeanor theft.

On that day, the defendant and the victim; [REDACTED] had exchanged words in the parking lot after the defendant accused the victim of bumping her vehicle with his car door while he took a cooler out.

The defendant, committed the crime of theft when she entered the restaurant took a set of cutlery, and exited the restaurant without paying for them. The restaurant, TEXAS ROADHOUSE advised that they would like to pursue charges as the defendant took the set of cutlery, passed all points of sale, and stole the items to commit another crime. The cutlery set was valued at five dollars.

The defendant then exited the restaurant with the steak knife in hand and used it to damage the victim's vehicle, a silver Honda CRV that was parked next to the defendant's vehicle. The defendant can be observed on camera that she circled the victim's vehicle before she left the location. A witness, [REDACTED] observed the defendant commit the crime and also noticed the damage around the vehicle and notified the restaurant manager.

The damage included all four doors of the vehicle and the passenger rear panel of the vehicle. The estimate for the damage was \$3,300.24.

On June 10th, 2024 at approximately 09:45 hours contact was made with the defendant. Post Miranda the defendant admitted that she committed the crime of criminal mischief against the victim's vehicle out of frustration. In regards to the theft, she claimed that the restaurant provided her with the cutlery set.

The defendant was taken into custody and transported to ACSO DOJ without incident. She was booked for one count of felony criminal mischief and one count of misdemeanor theft.


