The VICTIM, and the DEFENDANT, Rolando Perez-Perez, are married and reside together at the incident location and have two children in common.

The VICTIM was sleeping in bed with the DEFENDANT when she woke up to the DEFENDANT removing the blanket that was covering her. The VICTIM thought the DEFENDANT was waking her up intentionally so she asked the DEFENDANT to stop. The DEFENDANT then mounted the VICTIM and wrapped his hands around her neck. The VICTIM was laying on her back on the bed with the DEFENDANT sitting on her torso while his hands were applying pressure and force to her neck, strangling her.

The VICTIM demonstrated to me, using her own hands, how the DEFENDANT grabbed her neck. The VICTIM brought both hands to her own neck, wrapping them around it. I observed bruising and red marks on the front of the VICTIM'S neck, consistent with strangulation. I also observed a small scratch on her left cheek near the VICTIM'S nose that was lightly bleeding.

The VICTIM lost consciousness during the initial strangulation, and was unable to recall how long she was unconscious. When the VICTIM regained consciousness, her daughter and WITNESS, was in the bedroom and intervened. The WITNESS was able to separate the VICTIM and DEFENDANT and escorted the VICTIM to a different bedroom. Moments after the incident, the VICTIM vomited into a bucket. I observed vomit in a white plastic bucket near-by the VICTIM.

ACFR responded to the incident location as the VICTIM was experiencing strong pain in her neck area, dizziness, and blurred vision. The VICTIM was transported to NFRMC at Millhopper for further treatment.

Post Miranda, the DEFENDANT stated when he woke up this morning, he decided he was going to kill his wife, the VICTIM. The DEFENDANT then described in detail how he attacked the VICTIM with the intent to kill her. The DEFENDANT said he woke up, mounted the VICTIM while she was still sleeping in bed, wrapped both of his hands around her neck and began strangling her. The DEFENDANT stated the VICTIM tried to fight him and started hitting him with her hands. The DEFENDANT stated he continued to strangle the VICTIM until she lost consciousness and she started foaming at the mouth. I observed small fresh scratch mark with dried blood on the DEFENDANT'S right cheek, consistent with the VICTIM'S defensive actions.

When the VICTIM regained consciousness, she attempted to get away from him. The DEFENDANT said he chased after the VICTIM, grabbed her from behind, wrapped his arms around her neck, and continued to strangle her until the WITNESS walked into the room and yelled at him to stop.

The DEFENDANT claimed he released the VICTIM and walked out of the room towards the kitchen where he armed himself with a knife. The DEFENDANT stated he armed himself with the purpose to end his own life but was stopped by his son, The DEFENDANT stated his son removed the knife from his hands and held him against the couch in the living room until law enforcement arrived.


The DEFENDANT admitted to me that if the WITNESS had not walked in the room when she did and the DEFENDANT stated he would have killed the VICTIM. The DEFENDANT could not explain to me why he woke up with the urge to kill his wife.

I made contact with the WITNESS who stated she heard a commotion in her parent's bedroom and went to see what was going on. Upon entering, she saw the DEFENDANT standing behind the VICTIM, holding her in a "choke hold". The WITNESS then demanded the DEFENDANT to release the VICTIM and he complied. The WITNESS then removed the VICTIM from the bedroom and moved her to a different room in the residence.

Based on the statements made above, it is clear the DEFENDANT intentionally committed an act that could have resulted in the death of the VICTIM, by strangling the VICTIM to the point of unconsciousness. The
