Contact was made with the VICTIM in the roadway outside of Lot 125 upon arrival. The VICTIM appeared to be crying hysterically and physically shaking. The VICTIM was accompanied by a neighbor who stated that he heard her screaming during the incident. The neighbor also stated that the VICTIM utilized his phone to call 911. The neighbor did not wish to disclose his information during my time on scene.

Per the VICTIM's statements, the incident stemmed from an ongoing argument over accusations of infidelity. As the VICTIM was laying in her child's bedroom, the DEFENDANT entered the room and instructed the VICTIM to leave the home. The VICTIM noted that the DEFENDANT was intoxicated and irate over her changing her Facebook profile picture. The VICTIM agreed to leave the residence only after she put on a change of clothes. Despite this, the DEFENDANT physically grabbed the VICTIM by her ankles and drug her out of the room through the home. The VICTIM repeatedly screamed for help as the DEFENDANT drug her throughout the house.

As the VICTIM was drug near the door to exit the residence, she was able to slightly open the door and scream for help in hopes that a neighbor would hear her. The VICTIM attempted to push the door open, but the DEFENDANT overpowered her efforts and shut the door in an effort to prevent anyone from hearing her scream. The DEFENDANT continued to drag the VICTIM by her wrists and ankles. The VICTIM admitted to physically grabbing the DEFENDANT by his shirt in the process in an effort to stop him from further harming her.

The VICTIM then stated to the DEFENDANT that she would leave if he simply allowed her to change her clothes. The VICTIM asked the DEFENDANT to allow her to change clothes due to him pulling her pants down as he drug her throughout the home. The DEFENDANT allowed the VICTIM to do so. The VICTIM then changed her clothing and retrieved her cell phone and keys prior to exiting the home. The VICTIM informed the DEFENDANT that her intent was to leave the home and go charge her cell phone. This upset the DEFENDANT, which led the VICTIM to state that she planned to call 911 once her cell phone was charged. With knowledge of the VICTIM's intent to call 911, the DEFENDANT then physically snatched the VICTIM's phone and keys from her possession.

The VICTIM ran out of the residence to her neighbor's house, who heard her original screams for help. The neighbor allowed the VICTIM to call 911 from his phone. Following the call to 911, the VICTIM and neighbor observed the DEFENDANT leave the scene in a green Ford Ranger truck.

The vehicle and DEFENDANT were later located at a relative's home within the mobile home park. Upon making contact with the DEFENDANT, he repeatedly stated that he was not worrying about going to jail stating that these charges would be dropped and ultimately citing that he did nothing wrong. A relative turned over the VICTIM's cell phone which was located inside of their residence that the DEFENDANT exited from.

I observed the VICTIM to have injuries consistent with her recollection of the incident. The VICTIM had very apparent redness and scratches on both feet and ankles, both knees, and both hands and wrists. The VICTIM also appeared to have a minor abrasion on her back which she attributed as being rug burn from being drug across the carpet of the home. All injuries were photographed for evidence purposes.

The DEFENDANT was read his Miranda Rights by law enforcement personnel on scene. The DEFENDANT refused to speak


with deputies and stated that he did not speak English. However, during the time on scene, jail transport time, and booking time in the jail, the DEFENDANT spoke English.

- False imprisonment, in accordance with F.S.S. 787.02.2
- Robbery by sudden snatching without a weapon, in accordance with F.S.S. 812.131.2b
- Deprivation of 911/hindering witness communication with law enforcement, in accordance with 914.22-1e
