Upon my arrival, I made contact with the victim,


The victim stated that the male suspect had the RTS driver, Tramus Warren, hold the bus for the female suspect in the area of 2100 SE 35th ST. Once the suspects were on the bus, the victim told them that they should be on time, as they could be inconveniencing others, leading to a verbal agument. Shortly thereafter, the victim got off of the bus at 1400 SE 35th ST. The male suspect exited the bus, pushed Richard down, and began to batter him. The victim stated that he was punched in the right side of his face a few times and kicked in his right hamstring. As this occurred, the female suspect spat on the victim, while she was still on the bus. He wiped the spit away. The victim stated that the kick caused a "charlie horse", but otherwise did not complain of injury. Of note was a grass stain on his left pant leg and possibly a dirt stain on the lower left of his shirt.

I later reviewed the RTS bus surveillance video and believed the suspects to be David Ellison JR and Shanesha Young, based on prior history with them. The victim later positively identified David as the male suspect from a photographic lineup. The victim was unable to positively identify the female suspect from the photographic lineup, but stated Shanesha most resembled her.

A search of the defendant's criminal history revealed a previous battery conviction in Gilchrist County on 10/24/2022, Court Case number 212021MM000176MMAXMX.

The defendant, David Ellison Jr, is being charged with battery on victim over 65.


