200	However, upon review of the traffic camera footage, the DEF can be viewed picking the VIC up by the arms and slamming his body into the sidewalk. Furthermore, the DEF is observed striking the VIC with closed fists in the torso, arms, and face. This resulted in the VIC sustaining several small lacerations and bruising to his arms. In addition, the VIC's top lip was busted and he was bleeding profusely from his mouth. Post Miranda, the DEF admitted to physically restraining the VIC. He did not admit to striking him repeatedly into the ground. The DEF's injuries are inconsistent with physical restraint and corroborate the traffic camera footage showing the DEF intentionally and repeatedly striking the VIC until law enforcement arrived.
