Probable Cause

Ponzo Robinson III, hereafter referred to as the defendant, did unlawfully threaten properties of the victim, with a deadly weapon, in such a manner as to place her in well-founded fear for her own physical safety, thereby committing the crime of Aggravated Assault with a Deadly Weapon. The defendant also unlawfully touched, grasped and struck the victim, thereby committing the crime of battery. The defendant and the victim are married to one another, and reside together as members of a single household.

These facts were discovered in the course of a call for service, which deputies responded to upon receiving a 911 call indicating that the defendant and victim had been engaged in a struggle over a firearm. Upon arriving on scene, it was discovered that the defendant had approached the victim and attempted to engage her in a conversation, to which the victim indicated to the defendant that she was not interested in speaking with him. Upon being turned away, the defendant, who was visibly intoxicated at the time of the call for service, became extremely frustrated and made statements indicating that he was going to arm himself with a firearm for unknown and vaguely threatening reasons.

The defendant began walking across the home to a room in which the victim knew the defendant to possess at least one firearm, and armed himself with a shotgun. The victim attempted to prevent him from obtaining the firearm, at which time the defendant engaged in a physical struggle with the victim. The defendant, who is significantly taller than the victim, fought the victim to prevent his disarmament and in doing so placed the victim in a "head lock," trapping her neck with his arm against his torso. This struggle was witnessed by the victim's daughter, who resides in the same residence as the defendant and victim. This struggle took place while the defendant was armed with a deadly weapon, namely a shotgun, and placed the victim in clear and present danger to herself and to others in the home, especially considering the defendant's intoxicated and emotionally unstable state.

The defendant displayed injuries to the backs of his hands and arms consistent with the actions described by the victim, in which she tried to take the firearm from the defendant to protect herself.

Of note, the victim became uncooperative with responding deputies after the defendant was taken into custody, however the statements made by both her and her daughter during the incident point conclusively to the defendant being the primary aggressor in the altercation.
