remodeling a home together and have resided in the same home as a family unit for approximately two months. This incident is domestic in nature.

On the incident date and time, the victim and the defendant began a verbal argument. The defendant stated he wanted an open conversation where he was free to discuss negative things. The victim asked the defendant when he would return to her to continue the conversation. The defendant told her he was tired and wanted to go to sleep. The argument escalated because the defendant could not give the victim a timeframe of when he would return to the conversation. It continued to escalate into a screaming match, during which the defendant, who was nude at the time, defecated in the middle of the room on the floor. At this point, the victim felt the defendant was mentally unstable and began screaming for help.

The defendant covered the victim's mouth with his hand to stop her from screaming, simultaneously covering her nose. The victim stated she told the defendant multiple times she could not breathe, but the defendant continued to press his hand harder. The victim said after they separated, the defendant stated he was only covering her mouth. While investigating, the defendant gave a very vague version of events, but did admit to defecting on the floor. The victim provided a consistent verbal and sworn written statement. Post Miranda, the defendant declined to answer any questions.

The defendant willfully and intentionally covered the victim's mouth and airway with his hand, suffocating her airflow, despite repeatedly being told by the victim she could not breathe. The defendant has been charged with DOMESTIC BATTERY BY STRANGULATION.


