



I hereby certify that the above named accused was committed to the custody of the Sheriff of Putnam County at 2330 o'clock P. M., on April 3, 2023 and the accused was immediately advised as follows:

ADVISE:

1. You have the right to counsel. You have the right to talk with and be represented by a lawyer.
2. If you are unable to pay for a lawyer, one will be provided immediately at no charge.
3. In order to secure your immediate release you must post a bail bond in the amount of \$ 70,000.
4. If you are unable to post that bond, you will be granted a First Appearance Hearing within twenty-four (24) hours before a County Court Judge who will consider either reducing your bond or releasing you on your promise to appear in court.
5. You should consider hiring, or at least talking with a lawyer before posting bail.
6. You have the right to communicate with your lawyer, your family or your friends and may complete without charge two (2) telephone calls to any location in this county. At your own expense you may make long distance calls.
