This PC was transferred to me from Gainesville Police Officer K. Boyett ID # 963 re: GPD Case number 24-11400:

The DEF and VIC dated for 3 years. They broke up about 1 month ago. Since then, the DEF has been sending the VIC text messages threatening to commit suicide in front of her. These messages have become increasingly threatening and erratic. After over 3 weeks of messages, the VIC sent the DEF a text message telling the DEF to stop texting her. The VIC also blocked the DEF's phone number. However, the DEF continued to repeatedly message the VIC. From 09/17/2024 to 09/28/2024, the DEF has sent the VIC over 100 messages from about 30 different phone numbers. Further, on 09/28/2024, the DEF went to the VIC's home approximately 3 times and left a series of handwritten notes on the VIC's car, totaling to 27 pages of notes.

In these messages, the DEF stated that he was not faking it, that he was depressed due to their brake-up and depressed because the VIC was ignoring him, that he wanted to show the VIC how bad it really was, that they could have been happy, and that he wanted to blow his brains out in front of her. The 27 pages of handwritten notes contained similar statements and included pleas for the VIC to call the DEF before it was too late.

The DEF is known to carry firearms to include a black handgun that he always keeps on his person and at least one long gun, possibly a rifle.

The VIC advised that the DEF has a history of threatening suicide during arguments, but has never escalated to this level. Due to the threats and the fact that the DEF was at her home on 09/28/2024, the VIC was in so much fear that she left her home to stay at an alternate location for her safety.

The DEF's continued contact via text messages and leaving handwritten notes outside the VIC's residence is malicious in nature, serves no legitimate purpose, and has caused significant emotional distress to the VIC. The DEF's credible threat to shoot himself in front of the VIC has caused her to leave her home out of fear that the DEF will shoot her or himself in front of her.

Post Miranda, DEF acknowledge receipt of the VIC's text asking him to stop messaging her. However, he then answered all other questions about the messages by stating, "I don't recall," and "It isn't important." DEF stated that he never threatened to do harm to the VIC so she should not have been scared of him.
