PROSECUTIVE SUMMARY
After about 1 hour I received a phone call from the VIC who advised that she was back home and was wondering why I wanted her to call. VIC had no clue that the DEF called 911. The VIC stated that she and the DEF got into an argument over politics. The VIC stated that the DEF had went to the VA in Ocala earlier in the day for his doctor appointment and when he returned he was acting weird towards her. VIC stated that the DEF has a history of alcohol abuse and she could tell that he has recently been drinking, the VIC stated because she knew that he was drinking she told him that she was over it which made him upset.
The VIC stated that the DEF placed his arm around her neck which restricted her from breathing. The VIC advised that the DEF knows how to make someone go unconscious. VIC stated that she felt herself going unconscious which led her to scratching and biting the DEF. the VIC advised that she even struck the back of the DEF head with a cologne bottle to break free of the DEF choke hold.
WIT1 stated that she heard a lot of noise coming from the VIC room/ WIT1 stated that the banging sounded like someone was fighting. WIT1 Advised what caught her attention was when [redacted] yelled "GET OFF OF ME". WIT1 stated that she got up to go check on VIC but when she got to the bedroom door the VIC was walking out. WIT1 advised that the VIC looked exhausted and was breathing as if she was trying to catch her breath. WIT1 stated that that's when the VIC told her and WIT2 [redacted] to pack clothes to leave. WIT1 stated that she walked out of the apartment towards the car and the DEF came out behind them to retrieved they're cell phones and to keep the VIC from leaving with the car. WIT told me that because she refused to give up her phone the DEF started to become physical with her so the VIC got involved and when WIT1 saw that the DEF was getting to

WIT2 stated that she only saw the physical altercation between the VIC and WIT1 as the DEF was attempting to take their phones.
When I first arrived to the LOI I spoke with the DEF, when I left and returned due to VIC returning to the LOI, the DEF acted as if he had swallowed pills. DEF threw up prior to EMS arriving and there were no signs of pills inside his throw up. DEF was conscious and breathing but could not speak with us at the time.
DEF was transported to the VA for a Medical emergency
Defendant was identified by RMS.
