## PROBABLE CAUSE AFFIDAVIT

Before me this date personally appeared Ofc. C.Davis who being first duly sworn deposes and says that on the 07th day of November, 2024, at 3000 NW 83rd St. Gainesville, FI (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe same are as follows:

On 11/05/2024 an anonymous tip came in via online reporting that a student identified as Jordan Tucker has been carrying a firearm with him in his back pack while attending classes on the Santa Fe College NW campus. A search of Tucker's class schedule reveleaved that he would be attending classes at 1230 hours on today's date located in Building-B. Myself and Sgt. Manibusan responded to the class room and made contact with Tucker as he was walking into the building. Tucker was informed of the accusation and was asked if we could conduct a search of his bag. Tucker responded "fuck" and advised he may have something in his backpack. Tucker agreed to talk with us prior to being read his Miranda Rights. Post Miranda read by Sgt. Manibusan, Tucker waived his right to speak with us but spontaneously uttered that he had two firearms in his backpack that he forgot to remove before attending class. Tucker was then detained (handcuffed double locked and checked for safety fit) by Sgt. Manibusan. Tucker advised that he works at the Harry Beckwith gun store and sells firearms. Tucker claimed that he had recently been at gun show in Miami and forgot to take two personal firearms out of his bagpack. A search of his bag revealed two 9MM hand guns, a mask and gloves. Both firearms are 9mm Sig Sauers, one being a P938 loaded with seven rounds with one round chambered and the other P320 unloaded but 2 fully loaded extended magazines with 24 rounds each were located in he bagpack as well. Tucker was advised he was under arrest per FSS: 790.06 (12) (A9), possession of a firearm on school grounds. Tucker was transported to SFPD for further processing.

Photos were taken of the firearms and the weapons were placed into evidence at the Santa Fe College Police Department. A criminal history check revealed that Tucker had no prior arrests or criminal convictions. An FCIC/NCIC check of the serial numbers for the firearms came back clear. Tucker was transported to the Alachua County Jail without incident. Body camera footage is available.
