

On the above date and time, the DEFENDANT (Richard Curtis Moyer) wantonly and maliciously grabbed a bb gun and shot a metal projectile towards the Victim's residence.

The Victim _______ stated he was sitting on the couch inside his residence while his children were playing in the backyard. The VICTIM heard a "loud crack" on the living room window which was right behind the couch. The "loud crack" sounded like the impact of a small object which had great velocity. The VICTIM went into his backyard and made contact with the DEFENDANT who was standing in his backyard. The VICTIM asked the DEFENDANT if he shot something at his window to which the DEFENDANT stated "I'll blow that back window up unless those kids don't shut up". A backyard camera captured the incident. The VICTIM stated he saw the DEFENDANT with a wooden stocked BB gun which he described as a "Red Rider" in his hands when he confronted him outside. In the footage you can see children playing in the backyard. A loud noise can be heard followed by a loud high pitch of impact against a hard surface. A camera inside the residence captured the view from inside the living room. In the video, I observed the VICTIM sitting on the couch. A loud cracking sound can be heard on the footage's audio and the VICTIM's immediate reaction was observed.

The DEFENDANT was Mirandized and waived his 5th Amendment Rights. Post Miranda, the DEFENDANT admitted to grabbing a BB gun and shooting the BB gun several times towards the residence. The DEFENDANT stated he was shooting at the fence because he wanted the VICTIM's children to stop yelling. The fence that separates the backyards is approximately six feet high from the ground. The approximate trajectory would have place the projectile striking at chest to head level.

Based on the totality of the circumstances, to include statements and camera footage the Defendant is being charged with one count violation of F.S.S. 790.19 SHOOTING A DEADLY MISSILE INTO AN OCCUPIED DWELLING. The DEFENDANT wantonly, maliciously shot at an Occupied dwelling, which would produce great bodily harm.
