The staff at New Life also suspected Mr. Cloud was using however, he passed all urinary screens following the allegations. After speaking with Mr. Cloud, he advised prior to his current hospitalization at Memorial Hospital, he used about \$80 worth of cocaine because he was feeling hopeless. He felt that if people were already accusing him of using, he might as well use. It is the recommendation of the undersigned that Mr. Cloud be evaluated to determine if he continues to meet the criteria for conditional release.
