I have reviewed Lieutenant Christman's Service Related Investigation concerning Officer Chris Davis not writing a report after investigating an altercation he investigated on February 23, 2019. The complainant alleged she was intimidated by Davis and this is why she told him she did not want to press charges at the time. I concur with Lieutenant Christman that Officer Davis acted in a professional courteous manner and the complainant stated that she did not wish for the other party to be arrested. Lieutenant Christman wrote that Davis could have been in violation of our Reporting Procedures Policy 82.200, which states a report will be written in "Any situation the officer feels may generate a citizen complaint" or "Any question exists in the mind of the officer as to whether an incident falls within the parameters described in this section should be resolved through documentation." Officer Davis believed he was dealing with a minor disturbance, involving mutual parties, with the party most likely the victim not wanting to press charges. As the policy is written, I find Officer Davis to be exonerated. However, the complainant at the time mentioned that she was possibly injured, though there were no apparent signs of injury and she was not specific how she was injured. Given that information, a report should have been written. Also, both Officer Davis and Officer Johnnie Colvin turned off their body worn cameras at the conclusion of the call and did not turn them back on when the complainant reengaged them. The officers should have turned their cameras back on. Both the report writing issue and the body worn camera issue will be addressed through training.

Reviewer comment:

Boys and Girls Club- On 12/14/21 Officer Davis requested a cancelation and sent out a message approximately 1 hour prior to the detail. Officer Davis failed to notify the on duty supervisor that he would not be able to attend, which is in violation of FPPD Policy 22.900 Secondary/Off Duty Employment. The detail was left unfilled.

Boys and Girls Club- On 12/15/21 Officer Davis requested a cancelation and sent out a message approximately 5 hours prior to the detail. Officer Davis failed to notify the on duty supervisor that he would not be able to attend, which is in violation of FPPD Policy 22.900 Secondary/Off Duty Employment. The detail was left unfilled.

Boys and Girls Club- On 02/22/22 Officer Davis requested a cancel for the Boys and Girls Club detail scheduled for 02/25/22. Officer Davis did not send out any messages, alerts, or notifications of the vacancy. A replacement was not found and Officer Davis was not released from the detail. The detail was left unfilled and Officer Davis failed to notify an on-duty-supervisor. Due to these findings, Officer Davis was found in violation of FPPD Policy 22.900 Secondary/Off Duty Employment.

Boys and Girls Club- On 04/10/22 Officer Davis requested a cancel for the Boys and Girls Club detail scheduled for 04/15/22 due to a doctor's appointment. Officer Davis sent out a single alert stating "open" on 04/10/22. No replacement was found and Officer Davis was not released from the detail. Officer Davis contacted Sgt. McDermott the day of the detail. Due to these findings, Officer Davis was found in violation of FPPD Policy 22.900 Secondary/Off Duty Employment.

Boys and Girls Club-On 04/29/22 at 1437 hours Officer Davis requested a cancel for the Boys and Girls Club Detail scheduled for 1615hrs. Officer Davis then contacted Sgt. McDermott and Lt Cuti of the absence. No replacement

could be found and Officer Davis was not released from the detail. The detail went unfilled. FPPD Policy 22.900 does not outline if sudden sickness is an excusable reason to miss a detail. No policy violations were discovered.

There to provide general security".

In both details marked "No Show", Officer Davis notified the on duty supervisor and received permission to cancel the detail (documented in the CANCEL REQUEST comment section). In both details, he sent an alert message on PowerDetails notifying officers of the availability of the details. However, for the June 6 Detail, Officer Davis sent the message to the group POLICE OFFICERS (Nancy Barboza is not a member of this group). For the June 17 Detail, Officer Davis sent the message to ALL PERSONNEL (Nancy Barboza is a member of this group).

On August 31, 2022, The complainant \_\_\_\_\_ advised that her son \_\_\_\_\_, a "Free Black Man" was murdered on September 27, 2020, after he had been beaten, tortured, and threatened at the hands of four white Fort Pierce Police Officers.

## Conclusion of Facts:

- On September 27, 2020, \_\_\_\_\_ was found deceased in the rear shed of the residence by his mother. \_\_\_\_\_ appeared to have hung himself with an extension cord around his neck. \_\_\_\_\_ was observed in the kneeling position with his body weight pushing forward. Detective's investigations and the Medical Examiner's Autopsy report revealed that death was a suicide. There were no visible signs of trauma or suspected foul play and the case has since been closed.
- On May 7, 2021, the Office of Professional Standards received a complaint from \_\_\_\_\_, who expressed her concerns about how she was treated at the scene of her son's death. \_\_\_\_\_ alleges Fort Pierce Police Officers used excessive force against her when trying to remove her from the scene of her deceased son. The initial complaint was documented and assigned to a supervisor for review. Acting Sergeant Sobon completed the investigation.
- The following were his findings: During the week of May 7, 2021, Acting Sergeant Sobon received notification from the Office of Professional Standards to investigate the above citizen's complaint. On May 12, 2021, at approximately 1245 hours, he responded to \_\_\_\_\_ to speak with \_\_\_\_\_. Acting Sergeant Sobon attempted to make contact with \_\_\_\_\_ regarding her allegation. \_\_\_\_\_ refused to speak with Acting Sergeant Sobon without her attorney present. Acting Sergeant Sobon provided \_\_\_\_\_ with a business card and asked to speak with her and her attorney when they are available. However, Acting Sergeant Sobon never received a phone call from \_\_\_\_\_ or her attorney.
- All the documents and evidence associated with this complaint were reviewed, including (case reports, supplements, and Body Worn Camera videos). After reviewing the BWC video





regarding this complaint, Acting Sergeant Sobon finds allegation of excessive force to be "Unfounded." On the video, Officers can be observed blocking from re-entering the crime scene numerous times. Officers Lawrence and Berger followed Fort Pierce Police policy and procedure by maintaining the crime scene's integrity. During this call for service, the Officers displayed professionalism and compassion with the highest standards of the Fort Pierce Police Department.

- also accused Fort Pierce Police Officers of falsifying a "Bogus report" under case number 20-. I reviewed all the documented reports, supplements, and BWC videos associated with the incident. I learned that son ( ) was the suspect in a sexual battery incident. Based on the information reported in the complaint, it appeared that did not have all the facts associated with the matter. She claimed that the Officers typed up a "bogus report." However, that was not the case, the victim called 911 and reported the incident to local Law Enforcement as she escaped away from the suspect.
- On December 10, 2022, I made contact with at her residence. Also present was the Pastor from her church and another family member. I had an extensive conversation with regarding her complaints and concerns. I took the time to listen to her concerns, and I later explained to why our Officers removed her from the scene and kept her away from her son's body at the time. was very delighted with the breakdown and the explanation that I gave her.
- also had other complaints that she wanted to discuss with me. However, the names that were brought up were not Fort Pierce Police Officers. I quickly explained to her that those individuals that she was referring to are Deputies and that they work for Saint Lucie County Sheriff's Office. I told that I could not speak about that incident or her son's interaction with those Deputies. I kindly explained to her that she needs to take this complaint to the Sheriff's Office Internal Affairs Unit.
- I also discussed her other complaint about Fort Pierce Police Officers falsifying a police report, and the Officers having her son as the primary suspect in the incident. I asked if she had a copy of the police report, she said yes. I asked if she was able to obtain a copy of the BWC for the incident, she said no. I explained to that everything in the report was told to the Officers by the victim who reported the crime. I told the Officers did not fabricate anything in the report, and we have the BWC video to prove that. As stated before, did not review the footage from the Officer's BWC. In the video, when Officers came in contact with her son ( ), the Officers treated him respectfully as he was also respectful towards the officers. The Officers never insulted him verbally or physically. was detained and placed in the back of a marked patrol vehicle and brought to the Fort Pierce Police Department for questioning as a suspect in a sexual battery case.
- After I met with , I obtained a copy of the Officers' BWC footage from our Body Worn Camera Specialist and gave her a copy to review.
- After reviewing all the reports, the BWC video, and the facts surrounding the complaints, I find that the allegations against our Officers (Alexander Quiles, Christopher Davis, Kenny Lawrence, Noah Clark, Sergeant Wachendorfer, and former Fort Pierce Police Department

Officers (Peter Berger /Port Saint Lucie PD, Kyan Gelin /Miami Dade PD) to be unfounded. The Officers did not violate state laws or Fort Pierce Police Department policies and procedures.

### Summary:

On November 17, 2022, at approximately 5:17 p.m. (1717 hours), the 911 Communication Center was notified that a boat had just beached at the Fort Pierce, Causeway Cove Marina. The caller advised that approximately 50 people exited the vessel and were observed running near the park and museum. Officer Christopher Davis was dispatched to the call and arrived at 5:23 p.m. (1723 hours); thirty-eight (38) seconds later, Officer Davis described the boat as a "party boat" and cleared the call, "Charlie 2."

At approximately 5:21 p.m. (1721 hours), 911 dispatchers received a call instructing Fort Pierce Police Officers and St. Lucie County Deputies that the complainant observed the people leaving the beached boat, possible immigrants, now walking across the bridge near the Causeway Cove Marina. At approximately 6:10 p.m. (1810 hours), 14 Haitian immigrants were located and detained by FPPD officers and SLCSO Deputies; by 6:24 p.m. (1824 hours), 25 male and female Haitian immigrants were located and detained.

The Department of Homeland Security was contacted and responded to the scene; the Haitian immigrants were later transported to the St. Lucie County Jail, where they received medical care, food and were administratively processed.

### Conclusion of Facts:

- Officer Christopher Davis received the 911 dispatched call at 1717 hours; regarding a vessel that was beached at the Causeway Cove Marina, with several people exiting the boat and running. Upon his arrival, Officer Davis said he saw the boat beached on the sandbar but assumed it was just a "party boat." He failed to inspect or have the boat checked for injured people or illicit contraband. Officer Davis cleared the call 38 seconds after arriving on the scene.

- Following this incident, it was discovered that Officer Davis failed to activate his Body Worn Camera subsequent to responding to the initial dispatched call.

Therefore, I find that Officer Christopher Davis violated Fort Pierce Police Department Policy/Procedure(s):

*42.200- Criminal Investigation Procedure, "C. The preliminary investigation will include, but not be limited to, 2) Determine if an offense has occurred and the nature of the criminal offense."*

*83.130- Body-Worn Camera, F. Body-Worn Camera User Guidelines, "2. Officers should activate the BWC when responding to calls-for-service or engaging in any official Law Enforcement matter, as defined in Section D of this policy and as indicated: f. All calls-for-service."*

### Statement of Violation:

On November 17, 2022, you responded to a call-for-service regarding a vessel that was beached at the Causeway Cove Marina. The dispatcher advised that several person(s) were seen running from the boat. After arriving, you observed the vessel but failed to adequately investigate why or who beached the vessel and if any person(s) were onboard the boat. You also did not activate your Body Worn Camera when responding to this call. After approximately 38 seconds, you cleared the call-for-service and dismissed it as a beached "party boat." However, it was later discovered that the vessel was used to bring over several Haitian immigrants; 50 (fifty) of these persons were located and detained in the immediate area of the Causeway Cove Marina minutes after you cleared the call-for-service.

*This is to serve as notice to you that your action(s) mentioned above or the work product described is inconsistent with the standards expected of you or that is required of you by law, City of Fort Pierce Rules and Regulations, or Fort Pierce Police Department Policy and Procedures.
