County Sheriff's Office (ACSO), I received an email from Florida Department of Law Enforcement (FDLE) in reference to a sexual predator who had a change of address. The sexual predator was Thomas Lee Dowling (DEFENDANT).

The "Sexual Predator Act" per FSS 775.21 requires the Sheriff's Office to notify the community and the public of a sexual predator's presence in the community, due to a change of address. Before I create a media release of a sexual predator, I conduct a query of the individual through the FDLE sexual predator/offender state-wide database, which accessed by law enforcement to verify the new permanent address provided by the induvial.

I reviewed Dowling's information through the FDLE state-wide database and retrieved the following information: On November 20, 2018, Dowling was designated a sexual predator by the competent authority of the court in Alachua County, Florida following a conviction of Sexual Battery by Adult on Victim 12-17 years of Age/Injury not Likely per FSS 794.011(5)(a). Because Dowling is a designated sexual predator, he is required to register four (4) times a year, on his birthday month (November) and every three (3) months thereafter (February, May, and August). On January 6, 2025, Dowling registered as a sexual predator at the Alachua County Sheriff's Office Department of the Jail (ACSO-DOJ), and provided a new permanent address of 943 NW 34th Ave. Gainesville, Alachua County, Florida. Prior to Dowling residing at his new address he had a transient address of 3055 NE 28th Dr. Gainesville, Alachua County, Florida. Upon further review, I found that Dowling's Florida identification did not reflect his new permanent address, as his identification card showed his previous transient address (General Delivery with a zip code of 32609).

Each time Dowling's Florida identification card is subject to renewal, or within forty-eight (48) hours after any change in his permanent, temporary, or transient residence or change in name made by marriage or other legal process, Dowling must report in person to a driver license office to update his identification card and ensure the identification card has the correct designation (sexual predator or FSS 943.0435 for offenders). As of January 9, 2025, Dowling has failed to report to the driver license office to update his Florida identification card with his new permanent address.

When Dowling registered at the ACSO-DOJ on January 6, 2025, he was provided with the FDLE Sexual Predator/Offender Registration Form along with the Notice of Sexual Predator and Sexual Offender Obligations. The six (6) page document outlined what is required of Dowling as a sexual predator in the State of Florida. Dowling signed the document stating he had read or was read the six (6) page document and understood what was required of him. The forty-eight (48) time period has passed from January 6, 2025 for Dowling to update his Florida identification, and there is no grace period. Dowling has been charged with one (1) count of Failure to Report to DHSMV per FSS 775.21(6)(f).
