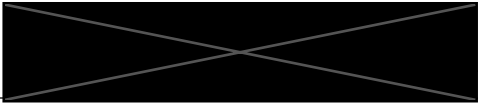

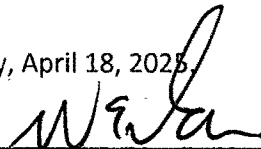
NOW THEREFORE it is ORDERED that the Public Defender is appointed to represent the above named defendant/child.
