Both the state and the defense were given the opportunity to present evidence to the Court, and both stipulated to the report filed with the Court from Hannah Williams, B.A., Forensic Specialist with Meridian Behavioral Healthcare, Inc., dated Tuesday, January 09, 2024, stating the defendant is competent to proceed. The Court has reviewed the report and received it into evidence. It is the FINDING of the Court that the defendant is competent to proceed. This finding is based in part upon the opinion stated in the report of the aforementioned.

1. The defendant is now competent to proceed.
2. The Clerk of Court shall transfer this case back to Felony Division I and set it for a Case Management Conference on **Tuesday, February 13, 2024, at 2:00pm in Courtroom 3B** of the Judge Stephan P. Mickle Sr. Criminal Courthouse, 220 South Main Street, Gainesville, Florida.


