On the above date and time at the mentioned location, the DEF was upset because of ongoing parking issues with neighbors. The DEF armed himself with flame thrower and exited his residence. The DEF walked out onto a public roadway and began spraying the flame thrower in the direction of VIC1's vehicle. The XM42 Lite Flamethrower sprays out flames up to 20 ft long.

VIC1 was sitting in the front driver's seat. VIC2 was sitting in the front passenger's seat. VIC3 was sitting in the rear driver's side seat. VIC1, VIC2 and VIC3 were

interviewed separately and gave the same account. They were sitting in VIC1's vehicle when they saw the DEF walk towards them with the flame thrower and start spraying it. The DEF sprayed within approximately five feet of the vehicle. They stated they were in fear of being burned and the vehicle catching fire. VIC told the DEF you better not burn up my car then jumped over to the passenger's side of the vehicle to escape. All VICs jumped out of the vehicle on the right side passenger's side of the vehicle and fled as the DEF was spraying the large flames in their direction. VIC1, VIC2 and VIC3 stated they were in fear of getting burned and the vehicle catching fire. VIC1, VIC2 and VIC3 are juveniles.

I read the DEF Miranda Rights from a standard Miranda card issued by GPD. The DEF stated he has had ongoing issues with the parking and came outside with his flame thrower to use it. The DEF admitted to spraying the flame thrower near the vehicle but denied targeting the VICs. He stated if he wanted to burn the vehicle, he could have. There have been multiple reports of the DEF using the flame thrower to intimidate subjects in the neighborhood.

The DEF was identified by his FL DL.
