inmate battery; where Victor Bruce (defendant) battered Joshua Terrell (victim).

The victim and defendant are both incarcerated at the Alachua County Jail in the same area. The defendant was seen on video going into his cell where he obtained a cup. The defendant then walked to the victim's cell, opened the door and threw the contents of that cup onto the victim against the victim's will before walking back to his cell.

The victim stated that the liquid that was in the cup was yellow in color and his clothes smelled of urine afterwards.

Post Miranda, the defendant stated that prior to the incident he was in a verbal altercation with the victim in the common area of the POD and the victim spit on him and called him the "N" word. The defendant stated that due to his childhood trauma he blacked out and the next thing he remembered was reading his book inside his cell. The defendant did not recall any other details about the incident.

Video footage was obtained from the DOJ and it corroborates the victim's statement. It should be noted that at no point did the video show the victim spitting on the defendant.

I am charging the defendant with battery by a detained person in jail FSS 784.082.3
