On 9/29/24 around 2315 hrs, GPD responded to 4121 Ne 15th St (Lewis Place Apartments) in reference to reports of numerous shots fired in the area. Upon arrival, GPD LEO found dozens of spent shell casings of .223 and 9mm in the area of Ne 15th St which borders the west side of Lewis Place. GPD LEO confirmed that numerous of the bullet projectiles struck multiple occupied residential apartments, including Vic1 and Vic2's apartment. The other victims will not be named in this arrest narrative. No persons were struck with a bullet during this shooting incident. Vic2 stated to LEO that Vic1 was staying at his apartment the night of the shooting and that he (Vic2) was in the process of taking

PROSECUTIVE SUMMARY - CONTINUED	out the trash when the shooting started.					
	While investigating this shooting incident, GPD LEO intercepted numerous voice message and text message communications via search warrant. GPD LEO confirmed that the Def was in consistent communication with Vic1 and Vic2 for several days leading up to the shooting, as well as multiple days after the shooting. The conversations were confrontational and the Def made threats indicating he would harm Vic1. On 9/26/24, the Def states to Vic1 "Bruh do you wanna die or what". The Def states that he owns a firearm that has a "switch". LEO knows that a "switch" enabled gun is a pistol firearm that has been modified into a fully automatic weapon. LEO also located numerous videos of the Def in possession of pistol firearms (switch enabled) and a black rifle in the fall of 2024 (via search warrant).					
	On the day of the shooting, Vic1 and the Def were arguing via messages and Vic1 told the Def that he could be found in Lewis Place. Approximately 5 minutes after the shooting, the Def is messaging Vic1 and Vic2 taunting them for the shooting. The Def states "stop doin all that running bro" and "told you you a bitch". Over the course of a couple of days following the shooting, Vic1 and the Def are in conversation about the shooting and the Def clearly explains how he was responsible for shooting at Vic1 and Vic2 from a vehicle, along with other unidentified Co-Def's. The Def states the following via voice and text messages:					
	- "Tell [redacted] (Vic2) to stop taking out that trash in the middle of the night thinking that shit gone be sweet"					
	- "I was there I can tell you who all was there fn"

<p>- The Def can prove he and his Co-Def's used a "big draco bitch, switches nigga" to commit the shooting and "you heard it nigga"</p> <p>- "We were parked in the back of the gate, over there where the gate at, in the back, where yall be posted up, where yall be at, posted up right there, and then we drove and seen yall, clapped (shot) at yall"</p> <p>- "We parked in da back where you can't go in or out where y'all be at back there"</p> <p>- "In then when it happened we was riding around still looking fa y'all"</p> <p>The Def clearly claims responsibility for the shooting incident and properly identifies the firearms used (big draco = .223 rifle, switches = 9mm automatic pistol).</p> <p>The Def is a self proclaimed "Village Green" gang member and commonly associates with other known Village Green gang members. Further review of the communications confirmed that the Def committed this act against Vic1 and Vic2 because several hours prior to the shooting, Vic1 openly disrespected numerous dead gang members when in communication with the Def. Vic1 and Vic2 claim associations with "The South" which is an opposing gang to the Village Green gang. This shooting incident was a gang sanctioned criminal incident in order to further the reputation and credibility of the Village Green gang. This shooting was retaliation for Vic1 disrespecting deceased gang members associated with the Def's criminal gang.</p>
