On November 3, 2023, at approximately 0438 hours, Law Enforcement Officers responded to [REDACTED] in reference to a person shot. Upon arrival, officers located the victim lying face down on the ground with a single gunshot wound to his neck. The Victim's three necklaces were scattered on the ground next to him, indicating a struggle transpired. The victim was transported to UF Shands hospital with a life-threatening injury.

Officers made contact with Witness 1 who stated he lives at the residence and was

present at the time of the shooting. Witness 1 explained to Your Affiant (YA) that prior to the shooting, Witness 2 came over and said the Victim had money to purchase drugs from the Defendant. Witness 1 called the Defendant via phone and gave the phone to Witness 2, who told the Defendant the Victim wanted to purchase drugs from him for \$100. The Defendant agreed to come to Witness 1 residence to meet the Victim.

Approximately 40 minutes later, the Defendant arrived at Witness 2's apartment. Witness 1 went to get the Victim from another apartment nearby and they came back together to Witness 2's apartment. At this point, the Victim, Witness 1, Witness 3 and the Defendant are the only people inside the residence. Witness 3 was in the bedroom at the time of the shooting. Witness 1 confirmed a drug transaction was made between the Victim and the Defendant with the Victim receiving crack cocaine and the Defendant paying him \$100 in return.

Afterward, Witness 1 stated while he was speaking with the Defendant, he decided to leave the apartment to go to get some blunts. While the Victim was walking out, the Defendant was directly behind him. When Witness 1 turned his back briefly to get his key, he heard a gunshot. Witness 1 turned around and observed the Victim lying on the ground and the Defendant walking away from the area the Victim was shot. Although Witness 1 did not observe a firearm on the Defendant, he advised the Defendant was the only person around the Victim at the time the gunshot occurred, which was an enclosed porch.

Witness 1 stated after the shooting the Defendant left in a newer model Toyota Camry with black rims, a sunroof and no tint. LEO was able to determine the Defendant had

history with a 2021 Toyota Camry FL tag: 67CDSQ. LEO utilized License Plate Readers (LPRs) which revealed at approx. 0438 hours, the vehicle is at 1900 SW 42nd Street, at approx. 0454 hours, the vehicle is at the entrance of Pineridge NW 23rd Ter (northbound) and at approx. 0609 hours, the vehicle is southbound at 1900 SE 4th Street.

At approximately 0649 hours, LEO located the vehicle in the driveway at 1900 SE 4th Street Apt 77. LEO covertly monitored the vehicle for several hours. At approx. 1216 hours, LEO observed the Defendant exit the Apt 77. Upon sight of LEO, the Defendant fled, refused to stop and tossed a firearm prior to being taken into custody. The Defendant was transported to GPD station. Post Miranda, the Defendant requested to speak with a lawyer.

The Defendant has three felony convictions. On August 27, 2009, The Defendant was convicted of Possession of Firearm by a Convicted Felon (Court Case Number 012008CF004611XXXAXX).
