On 12/11/2024 at approximately 1343 hours seven Gainesville Regional Utilities (GRU) employees (VIC 1, VIC 2, VIC 3, VIC 4, VIC 5, VIC 6, and VIC 7) were replacing a meter at 2917 NE 10th Dr. Upon replacing the meter it was discovered that the residence had a gas leak further in the back yard which required emergency maintenance. The VICs fixed the gas leak and were in the process of taking their work equipment back to their marked GRU trucks that were parked in the roadway in front of the residence. As the VICs were leaving the back yard of the residence an individual fired a gunshot out of a bathroom window in the direction of the VICs. After the gunshot VIC 1 yelled that they

were leaving the property. The individual inside then fired a second gunshot out of the bathroom window. VIC 1 was walking past the bathroom window when the second gunshot was fired and said he could hear the projectile ricochet near where he was standing. All 7 VICs were in fear for their lives and ran away, some of which had to jump a fence into a neighboring yard. GPD patrol was in the area and heard one of the gunshots and responded immediately.							
VIC 1 said the day prior on 12/10/24 GRU left an official GRU note on the doorknob of the front door of the residence which stated they would be replacing the meter on 12/11/24. When they arrived the note was no longer on the door indicating that the resident received it. VIC 1 also said 30 minutes prior to beginning the work they knocked on several doors several times to inform the resident they would be working in the yard and received no answer. The residence has several exterior surveillance cameras and VIC 1 attempted to wave at the cameras in order to get the resident's attention with negative results.							
GPD set up a containment perimeter around the house and made several announcements for the individual(s) inside to exit and got no response. YA obtained a search warrant which was executed on 12/11/24. GPD SWAT entered the residence and it was discovered the DEF was the sole occupant and was sleeping in the master bedroom. Inside the master bathroom 2 spent .40 caliber shell casings were located on the floor below the window. The master bathroom window screen had 2 apparent bullet holes in the lower portion. The master bathroom window is where the VICs said the gunshots came from. A .40 caliber handgun was located between the mattress and bedframe in the master bedroom where the DEF was located. Several empty liquor bottles were also located in the DEF's bedroom
