On 5/13/25 around 2145 hrs, GPD LEO responded to the above location in reference to a report of an armed robbery. Upon arrival, LEO located the 66 year old female victim with numerous injuries and covered in blood. The Vic later received 12-15 stitches to the left side of her forehead, 12-15 stitches to her right ear, a broken left hand/wrist, and a broken nose. The Vic stated that a black male in a grey hoody had attacked her in the pool area of the complex by striking her numerous times with the butt of a pistol firearm. During the attack, the Vic stated the suspect also demanded she transfer money/cash to him. The Vic stated the suspect grabbed her

phone from her and attempted to send himself money but failed. The Vic stated the suspect stole her white gold ring (with three diamonds valued at \$1000) from her hand during the attack/robbery.

While LEO was investigating this incident at the apartment complex, and informant called CCC to report a black male in a grey hoody hiding underneath a truck inside of the complex. GPD LEO responded and located the Def hiding underneath a pickup truck while armed with two pistol firearms. The Def was ordered to surrender to police detention but the Def resisted by ignoring numerous commands to get on the ground. Once detained, the Def was transported to GPD. The Def was found to have smeared blood on his left leg and blood on one of the guns found in his possession (the .45 caliber pistol). All blood is believed to be the Vic's blood due to the Def not having any fresh bleeding wounds.

GPD LEO was able to follow a blood trail from the victims apartment that led LEO to the pool area. Located in the pool area were numerous .45 caliber rounds of ammunition that matched the ammunition found in the Def's .45 caliber pistol firearm.

LEO soon contacted the Wit who is the Def's girlfriend. Post Miranda, the Wit confirmed that she heard a commotion outside, exited her apartment, and observed the Vic on the ground yelling "Ahhhhh" while the Def stood next to the Vic.

Post Miranda, the Def stated he has been drinking heavy amounts of alcohol tonight. He confirmed he was in possession of both of his firearms tonight upon his arrest. He confirmed that he was angry with his girlfriend tonight. He was standing near the pool area in the apartment complex when the Vic started to record him. The Vic did not tell

He agreed that the blood LEO found on his gun likely belongs to the Vic. The Def complained of injury to his hand (likely due to him striking the Vic numerous times with the pistol butt).

LEO could smell a strong odor of an alcoholic beverage coming from the Def's person. The Def was ID via his Georgia DL.
