WHEREAS, Letitia Grant has made oath that on the 21<sup>st</sup> day of October, A.D. 2021 one Dawson Ley Tyler, hereinafter referred to as the offender, was placed on sex offender probation for the offense of Ct 1: Sexual Battery of an Adult Without Force to Cause Injury in the Circuit Court of Alachua County, for a term of 2 Years in accordance with the provisions of chapter 948, Florida Statutes, and that the offender has not properly conducted himself, but has violated the conditions of his sex offender probation in a material respect by:

**Violation of Condition (15) of the Amended Order of Sex Offender Probation**, by failing to comply with a mandatory curfew from 10 p.m. until 6 a.m., or another 8-hour period designated by the court, and as grounds for belief that the offender violated his probation, Officer Letitia Grant states that on 06/25/2024 at approximately 0339 hours, the offender was not at his residence in order to comply with the curfew, as evidenced by the attempted home visit on 06/25/2024.

**Violation of Condition (15) of the Amended Order of Sex Offender Probation**, by failing to comply with a mandatory curfew from 10 p.m. until 6 a.m., or another 8-hour period designated by the court, and as grounds for belief that the offender violated his probation, Officer Letitia Grant states that on 07/18/2024 at approximately 0028 hours, the offender was not at his residence in order to comply with the curfew, as evidenced by the attempted home visit on 07/18/2024.

THESE ARE, THEREFORE, to command you to arrest instanter the offender, Dawson Ley Tyler, and bring him before me to be dealt with according to law.

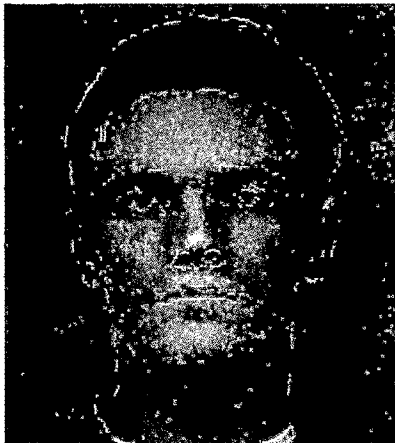
