Probable Cause

Within Alachua County, Jason Vordenberg, the DEFENDANT, conspired with his girlfriend, Amanda Copley the CO-DEFENDANT, to sell counterfeit Oxycodone Hydrochloride pills containing Fentanyl to the victim, Robert "Shane" Guzman. Upon consumption of these Fentanyl pills, Guzman overdosed and died on March 31, 2023. YA received copies of the Medical Examiner's Autopsy and Toxicology Reports. The "Cause of Death" for Guzman was listed as "Acute Fentanyl Toxicity":

During a series of communications beginning on March 29, 2023, and ending on March 31, 2023, Copley communicated with Guzman by cellphone to facilitate the sale of ten pills to Guzman. Guzman was a regular customer of Copley's, buying what he believed to be Oxycodone Hydrochloride pills, from her. When initially arranging the sale of pills to Guzman, Copley did not have the pills on hand, to sell. Copley also communicated with the DEFENDANT by phone, to arrange the obtain the pills she intended to sell to Guzman. Copley requested that the DEFENDANT contact Theo "Wayne" Whitfield, in order to purchase the pills from Whitfield, for Copley to then resell to Guzman. Whitfield was the DEFENDANT's source of supply for pills.

The DEFENDANT communicated by phone with both Copley and Whitfield facilitating the purchase of pills from Whitfield. The DEFENDANT then met with Whitfield in the area of 300 NW 252nd Street and purchased approximately 10 pills from Whitfield. The DEFENDANT then transported the pills, delivering them to Copley in the area of 25246 SW 17th Avenue. It is important to note that the location where the DEFENDANT delivered the pills to in order for Copley to complete the sale to Guzman, was approximately 898 feet from Newberry Elementary School, an elementary school located at 25705 SW 15th Avenue.

After the DEFENDANT delivered the pills to Copley, Guzman traveled to the area of 25246 SW 17th Avenue to meet Copley. Guzman purchased 10 pills for three hundred and fifty dollars (\$350.00) in US currency. Copley completed the sale of pills to Guzman just prior to midnight on March 30, 2023. Later, after the two parted ways following the completion of the drug sale, Guzman contacted Copley and questioned the legitimacy of the pills. Due to the pills being in a "busted up" condition and being green in color, the pills seemed suspect to Guzman. Copley reassured Guzman that the pills were genuine. Guzman replied to Copley, "I trust you, Im just checking" and then thanked Copley. Guzman was found deceased hours later within his residence located at 27215 SW 22ND Place. Green pills and a green powdery substance were among the items of evidence located at the scene. Evidence items were collected, processed, and later placed into ACSO Evidence. While processing the evidence at ACSO, some of the powder residue was field-tested. The powder field-tested positive for the presence of Fentanyl.

On April 27, 2023, YA made contact with and interviewed Copley and the DEFENDANT, separately. Post Miranda, the DEFENDANT and Copley both stated that the DEFENDANT purchased the pills from the DEFENDANT's source of supply, in order for Copley to then resell the pills to Guzman.
