In all respects live honorably, work diligently at a lawful occupation and support dependents, if any, to the best of your ability, and live within what income is available, or in the alternative, if appropriate, attend school on a full time basis. Live and remain at liberty without violating any law.

Conditions of Alachua County Supervised Probation are: 24

Report to the Alachua County Probation Office within 24 hours of the date of this Order excluding weekends and holidays. It is further ordered that you comply with all terms and conditions below within the first _____ months of your probation, in the manner directed by your probation supervisor. Should you change your residence, education or employment, notify your supervisor within 7 days. You may not move outside the county where you now live without permission from your supervisor or an order from the court. Until your release from probation, report to the Probation Office by the 10th day of each month or as otherwise directed by your probation supervisor. Truthfully answer all inquiries directed to you by your Supervisor and allow your Supervisor to visit your residence or employment site. You must undergo evaluation and comply with all conditions and treatment requirements of any alcohol, drug, mental health or employment programs as directed by your Supervisor or as ordered by the Court. Enroll within 60 days



Any active warrant, capias or summons in this case against this defendant is hereby quashed.


