NOTICE TO CEASE AND DESIST

You are hereby directed to cease and desist DEFAMATION OF CHARACTER AND REPUTATION OF FLORZELLE FIELDS JR, Mr. Florzelle Fields Jr. has learned that you have engaged in defamatory, online solicitation of defamatory rumors and information about him viewed on <https://www.gnvinfo.com> (see attached) and his character. Accordingly, it is demanded that you (A) immediately cease and desist (stop) any defamation to Mr. Florzelle Fields Jr. and (B) provide a prompt written assurance within three (3) days that you will cease and desist from further defamation of Mr. Florzelle Fields, Jr. character and reputation. If you do not comply with this cease-and-desist demand within this time, Mr. Florzelle Fields, Jr. is entitled to seek monetary damages and equitable relief for Defamation of Character, Slander, and Libel. In the event you fail to meet this demand, please be advised that Mr. Florzelle Fields, Jr. will pursue all available legal remedies, including seeking monetary damages, injunctive relief, and an order that you pay court costs and any attorney's fees. Before taking these steps, however, it is set forth to give you one opportunity to discontinue your illegal conduct by complying with this demand within (1) days or 24 hrs from this notice.

Thank you for your attention to this notice, if no conclusion is met, Mr. Florzelle Fields, Jr. will be directed to proceed with legal action against you and anyone who has caused harm.
