PROSECUTIVE SUMMARY - CONTINUED

The DEF made several spontaneous statements that this was self-defense. Witnesses on scene advised that the DEF had been drinking all morning and was being belligerent and loud outside of room #442. The DEF and the VIC got into a verbal altercation after the VIC asked the DEF to leave the property.

The DEF went into room #442, retrieved a handgun, and then confronted the VIC in the parking lot. The WIT advised she tried to stop the DEF and got between the DEF and VIC, but the DEF began shooting at the VIC over the WIT's shoulder. The WIT jumped out of the way and the DEF continued firing multiple shots. The shoulder of the WIT's shirt had a bullet hole in it but the WIT was not struck. The WIT said after the shooting the DEF went upstairs and fired another gunshot in an unknown direction from the balcony. The DEF resides in room #442 along with the two mothers of his children and seven children. Officers observed a handgun in plain view through the open door of room #442.

The VIC said he received a phone call that the DEF was arguing in the parking lot. The VIC drove to the Value Lodge and asked the DEF to leave. The VIC said the DEF began arguing with him. The VIC said the DEF went to his room and came back to the parking lot. The VIC said the DEF pulled out a gun and began firing at him. The VIC said he did not have a firearm with him or reach for anything prior to being shot. No firearms were located on the VIC or in the VIC's vehicle.

Post-Miranda, the DEF stated he and the VIC were in a verbal argument in the parking lot. The DEF said he went to his room to "cool off". On his way up to the room the DEF said he yelled "I will knock you out" to the VIC. The DEF said while he was upstairs

<b>PROSECUTIVE SUMMARY - CONTINUED</b>	<p>he armed himself with a handgun that belongs to the mother of his child. The DEF said he armed himself because he knows the VIC always carries a firearm however the DEF also said he does not know the VIC. The DEF said after arming himself he went back down to the parking lot to speak (Speak) with the VIC. The DEF said the VIC repeatedly used the N-word and it upset him. The DEF said he and the VIC continued arguing and he saw the VIC reach towards his waistband. The DEF said he believed the VIC was reaching for a firearm so he pulled the handgun from his pocket and fired at the VIC approximately 4 times. The DEF said he never saw a weapon on the VIC's person. The DEF said this shooting could have been avoided if he stayed in his room.</p> <p>The shooting was captured on video by the Value Lodge surveillance system and matched the WIT's account of events. The surveillance video shows the VIC standing still while the WIT appears to be trying to push/pull the DEF away from the VIC. Based on the surveillance video it does not appear that the VIC moves or makes any sudden movements until after he is shot at. As the WIT is trying to get the DEF away from the area the DEF pulls a handgun from his pocket and fires it at the VIC. The VIC continues standing and the DEF fires at the VIC again approximately 3 seconds after the first gunshot. The second set of gunshots struck the VIC, grazing his left thigh, his scrotum, and then penetrating his right thigh.</p> <p>The surveillance video clearly shows the DEF is the aggressor. Even after being physically removed from the area by the witnesses he arms himself and returns to the parking lot to confront the VIC.</p>
