| PROSECUTIVE SUMMARY                   | they heard two distinct gun shots come from the DEF's trailer prior to LEO arrival.   |  |   |
|                                       | LEO then attempted to make contact with DEF via the telephone. DEF was asked several times to exit the black utility trailer that she was hiding in, so LEO could speak with her. DEF refused to come out and speak with LEO. Several telephone calls were made to DEF in attempts to get her to exit the trailer and she refused. DEF kept making demands of LEO before she would consider exiting the trailer. DEF wanted LEO to lock the doors on her trailer and also wanted LEO to walk up to the trailer so she could speak with LEO. DEF also requested pictures from LEO to show where officers were stationed to determine whether LEO was too close to her trailer. During the several telephone calls with LEO, DEF mentioned that she had propane tanks, a loaded AR-15 rifle and two handguns. Based upon this information, it was not safe for LEO to approach the trailer. |  |   |
| CONTINUE                              | While still trying to communicate with the DEF, at approximately 0907hrs, the DEF fire one round from one of her firearms. LEO could not tell from where or what direction the DEF was aiming her firearm. When this round was fired, the original contact team was approximately 10-20 yards from the DEF. This placed all officers on scene in fear of potentially be struck by a projectile. This was an intentional act of both aggravated assault with a firearm on LEO and attempted aggravated battery on LEO.   |  |   |
|                                       | While LEO was actively attempting to negotiate with the DEF, the DEF pointed a firearm several times at the contact team placing them in fear as well.  |  |   |
| CONTINUE                              | LEO was continuing to try to communicate with the DEF to try and peacefully resolve this incident, the DEF again fired one round from one of her firearms at approximately  |  |   |

| During the course of communicating with the DEF, the DEF would again fire several more rounds. The DEF fired more rounds at approximately 1145hrs, 1157hrs, 1158hrs, and 1159hrs. Because the DEF recklessly and intentionally firing her firearms placed not only the original nine officers lives in danger, but also placed members of the community who were driving on public roadways, and customers of Walmart who were being sheltered in place inside the store and who were trying to leave the store to vacate the area. The DEF's reckless action also placed the additional resources needed for this incident in danger. Those resources were ASO, ASO SWAT, GPD SWAT, GFR, and ACFR. |  |   |                |                                      |         |   |  |
| The DEF while speaking with LEO seemed to be suffering from audio and visual exclusions. The DEF at times seemed to be talking to people that were not there and was also seeing people that were not there. At times making it difficult for LEO to communicate and negotiate with her for a peaceful resolution.  |  |   |                |                                      |         |   |  |
| With the assistance of GPD and ASO SWAT, the DEF was able to be taken into custody peacefully.  |  |   |                |                                      |         |   |  |
| During the course of this incident, the DEF not only resisted officer's efforts to peacefully resolve this incident by refusing to exit her trailer unarmed but also recklessly fired her firearm several more times preventing LEO from physically making contact with her. The DEF resisted officers without violence when she refused to come out of the trailer without any weapons.
