On Wednesday, July 2, 2025, at approx. 2245 hours, the DEF shot the VIC from the porch of 1144 NE 24th St using a 9mm semiauto handgun. The CODEF and WIT witnessed the shooting. Four 9mm shell casings were located on the porch of the LOI and preliminary analysis indicates they were fired from a single firearm and had characteristics consistent with being fired from a Glock.							
It should be noted, several days prior to the shooting, two handguns were stolen from a neighbor (see GPD CR# 02-25-009534) and were described as a brown Smith&Wesson M&P

PROSECUTIVE SUMMARY - CONTINUED	Shield that the CODEF admitted to possessing and a black Glock 19 that the CODEF stated the DEF possessed. Surveillance video from the LOI from the week leading up to the shooting shows the DEF and CODEF in possession of these two handguns. The DEF is most often in possession of the black Glock. The CODEF is most often in possession of the brown Smith&Wesson that has been recovered and excluded as the firearm that fired the four casings.								
	Prior to the shooting on July 2nd, the DEF, CODEF, and WIT were hanging out at CODEF's residence at 1140 NE 24th St and then the neighboring residence of 1144 NE 24th St (LOI). Both the DEF and CODEF frequent the LOI.								
	On July 2nd at approx. 2214 hours, surveillance video shows the DEF, CODEF, and WIT approach the LOI and sit together. The DEF has a dark-colored object that appeared consistent with a handgun in the pocket of his hoodie. The DEF was immediately recognizable to YA and other detectives from this video due to his face being visible and a distinct tattoo on his forehead/left temple. In a post-Miranda interview with YA on July 9, 2025, the DEF identified himself in the same video. He denied the object in his pocket being a firearm and stated it was a "rolled up beanie." The DEF admitted to being on the porch during the shooting and hearing 12 shots, but he advised he was not looking and did not see who shot the VIC. The DEF advised he ran away on foot. None of the DEF's statements were consistent with the evidence or other involved parties' statements.								
	The shooting was not captured on video. The VIC indicated to patrol officers the shooter was the CODEF because he saw the CODEF with a gun seconds before being shot. A few days

black handgun and it has not been recovered. The DEF is an adjudicated delinquent (see most recent court case 2022-CJ-000604-A) and cannot be in possession of firearms. In this same investigation, the DEF has been charged for the kidnapping of the WIT, attempting to tamper with the WIT from jail, and for possession of the firearm by an adjudicated delinquent.

The DEF's identity is known to YA and was confirmed via FL DL.
