The VIC said that an argument began after she found Instagram messages from another woman on the DEF phone. The VIC said that during the argument the DEF pulled her by her right arm and punched her in the left jaw line and forehead. The VIC said after being punched in the forehead she fell to the ground and hit the back of her head on the hard floor. The VIC said she must have lost consciousness because when she woke up everything was blurry. The VIC said that she sought medical attention later in the afternoon because she was afraid that maybe she had a concussion. The VIC had a visible knot on her forehead and a fresh red scratch marks on her upper right arm consistent with getting grabbed and punched. The VIC was at the hospital at the time LEO was made aware of the incident that occurred earlier in the morning. While LEO was on site with the VIC, the DEF came to the hospital specifically looking for the VIC. Post Miranda the DEF said that the VIC hit him first after seeing the Instagram messages. The DEF stated that he did grab the VIC but only to stop her from hitting him. The DEF could not specifically state where he was hit but that the VIC was just hitting him everywhere. The DEF stated he did not arrive at the hospital to find the VIC but was there for a previous gunshot wound injury, however, medical staff at the hospital confirmed that the DEF in fact walked in specifically asking where the VIC was. The DEF was positively identified via RMS photo.
