PROBABLE CAUSE

On 7/25/13 I responded to [REDACTED] Alachua FL, in reference to a battery that was possibly in progress.

Upon arriving on scene, I made contact with the defendant, Jacob Morris, who was standing in front of an Alachua Police Department patrol vehicle. Because the defendant was detained, I read him his Miranda Rights prior to asking him any questions. The defendant advised me that he understood his rights and wished to speak with me.

The defendant said that he and his girlfriend, [REDACTED] (victim), of approximately 3-5 months were engaged in a verbal altercation due to the victim wanting to consume alcohol. The defendant stated that the confrontation did not get physical.

I spoke with the victim, Teryra Fountain. The victim appeared to be intoxicated as she was having a difficult time forming a cohesive thoughts and had slurred speech. The victim stated that she and the defendant have been together for approximately 5 months and are currently engaged to be married. The victim stated that the defendant was yelling at her because she wanted to get alcoholic beverages. The victim stated that the defendant put his hands on her in an attempt to keep her from walking to the gas station to get alcohol. The defendant had a visible red mark on the right side of her neck.

Two independent witnesses saw the incident occur from the gas station. Both witnesses completed a sworn written statement attesting to seeing the defendant grab the victim in the area of her head and forced her to sit at a picnic table. Both witnesses statements confirm the same series of events.

The defendant was identified by his Florida driver's license. The defendant and victim confirmed that they are engaged in a romantic relationship and currently live together.

Because of the independent witness statements, I have probable cause to believe the defendant intentionally touched or struck the victim. I placed the defendant under arrest for domestic battery and transported him to ACSO DOJ without incident. The defendant was cooperative through my investigation.

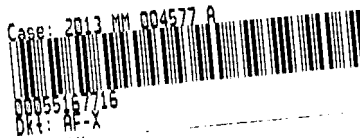
