PROBABLE CAUSE

Investigation revealed that the defendant, Jacob Morris, did commit the crime of domestic battery. The subject who is also a convicted felon in The State of Florida, had on his person a set of black brass knuckles.

The defendant and the victim, [REDACTED], have lived together in the past as a single family unit and have recently separated. However are still currently engaged to be married. This classifies the incident as domestic.

On 6/5/15 at approximately 2307hrs, I responded to the incident location, Napolitano's restaurant, in reference to a male subject allegedly "beating" a female. Upon approaching the location I observed a male and female arguing that matched the description given by the complainant.

The victim stated that she and the defendant had been involved in an argument regarding the defendant speaking to another woman on the telephone just prior to the incident. The victim left the location without paying the couples tab and began to walk home.

As she walked the defendant approached her in his vehicle and demanded that she get in and go back with him to pay the bill. She did so and returned to the business once at the business the two began arguing once they exited the vehicle. When she attempted to again walk away the defendant grabbed her by her arm and threw her to the ground. Due to these unwanted actions the victim sustained a large contusion on her left cheek and an abrasion to her left arm.

The defendant post Miranda admitted to grabbing the victim's wrist and "butt" area in an attempt to "guide" her back to the restaurant after she did not pay the bill. He denied ever pushing her down. Due to the defendant admitting to attempting to "guide" the victim back to the restaurant against her will after she attempted to leave and the injuries to the victim, he was placed under arrest for domestic battery.

Search incident to arrest it was discovered that the defendant had in his possession a set of brass knuckles, concealed in his pocket. The defendant has three prior felony convictions in the state of Florida. The defendant stated that he was unaware that carrying brass knuckles was against Florida law.

The defendant was transported to the ACOS DOJ without incident.
