PROSECUTIVE SUMMARY	The VIC felt that the DEF had the intention and ability to kill the VIC.		
	I observed the knife, it was a kitchen knife, with a light blue handle and silver blade, approximately 4 inches in length.		
CONTINUED	Lt. Lugo #411 arrived on scene and saw the DEF holding the knife in his right hand. The DEF then threw the knife on the ground when he saw Lt. Lugo.		
	WIT 1 and WIT 2 stated that the DEF had been arguing in the street with his girlfriend. WIT 1 and WIT 2 said they heard the DEF yelling outside and saw him weilding a knife in his hand erratically and threatening to rape and kill. WIT 1 and WIT 2 could not see who he was threatening.		
CONTINUED	Post Miranda, the DEF denied having a knife. The DEF also said that "he was not guilty of what I thought he was guilty of". I asked the DEF what he meant by that and he stated that he wasn't saying, "I will kill you" to anyone in particular.		
	The DEF was positively identified by his RMS photo.
