	The Def spontaneously stated that he was defending himself, despite LEO observing him approach and engage the subjects. Once detained, the Def advised he engaged in the altercation because the subjects were black, and that "LEO should understand".				
The Def was also visibly intoxicated. His breath emanated alcoholic beverages in the form of beer. He had glassy eyes, slurred speech, and could not stand without swaying. He also could not follow simple questions without repeating himself.
