Before leaving the courthouse today, you must go to the Office of the Clerk of Court, located on the 4th Floor, 220 S. Main Street, Gainesville, FL to arrange for payment. Payment plans are available if you cannot pay the full amount today. A payment plan incurs a one-time service charge of \$25.00. s. 28.246(4), Fla. Stat. If you fail to make arrangements today, the Clerk will send you a standard payment plan, and you will be responsible for making the payments. If you fail to make those payments, the Clerk will refer the matter for collections, which will result in the imposition of additional monetary sanctions including \$10 to record the civil judgment and suspension of your driver's license. If you absolutely cannot pay, you may petition the court to convert some of this total to community service hours. Failure to complete community service hours by the court-imposed deadline will cause the financial obligation to be reinstated.

☐ You are unable to pay the amounts due and your monetary obligations, consisting of Court Costs and Fees, are reduced to Civil Judgment, which shall bear interest at the rate prescribed by F.S. 55.03. Therefore, pursuant to Section 938.30(6), these financial obligations, including \$10 to record this judgment, are reduced to a civil judgment for purposes of enforcement and collection. Any balance remaining due on your civil judgment after 90 days from the date of this order will be referred to a collections agency.

If a bail bond is currently in effect as to this case and has not been forfeited, that bond is hereby cancelled and the surety is discharged from liability on that bond. Such cancellation and release of liability shall also apply to those bonds in effect and not forfeited in those enumerated cases listed below as being dismissed by a nolle prosequi.

A qualifying offender, per F.S. 943.325(1)(b)(5) is required to submit an FDLE-approved blood or biological specimen, F.S. 943.325(7). Unless the defendant has been declared indigent by the court, he/she shall pay the actual costs of collecting the approved biological specimens required under F.S. 943.325.

Any active warrant, capias or summons in this case against this defendant is hereby quashed.


