The DEF was located inside the residence, hiding in the closet of a secondary bedroom (used as an office) on the south side of the home. GPD K-9 officers made announcements that they were police and had a K-9 with them. The GPD K-9 handler loudly, clearly instructed anyone still inside the home to make themselves known and to come out with hands up. No one inside the home acknowledged the multiple announcements. K-9 Ranger was released into the home and quickly located the DEF inside the office. VIC1 and VIC2 have no idea who the DEF is, have never seen him before and very much did not ever gave him permission to enter the home. Following the DEF's arrest, the leasee of the home was walked through the home, to check for anything missing or disturbed. Inside of the bedroom where the DEF was found hiding in the closet of, a computer monitor was found to be found face-down, contrary to how it was left. VIC1 also pointed-out a laptop computer on the same desk. This laptop computer was open, but the VIC1 leaves it shut. It was also apparent that the DEF had rearranged several pair of the VIC1's shoes in a different spare bedroom. There was a plastic garbage bag on the ground by these shoes now, giving rise to suspicion that the DEF was preparing to pack several pair of the VIC1's shoes in to this garbage bag. VIC1's red Nike Air Max 15's were on the DEF at the time of the arrest. At the hospital, the DEF was advised of his Miranda Rights, and agreed to speak with LEO. Post-Miranda, the DEF kept stating that he is staying in an Air B&B rental house nearby (which is true) and that he just made an 'honest mistake' and walked in to the wrong house. The DEF further advised "they look exactly alike," however the DEF's Air B&B house is on the other side of the street from the victim's residence, and they look

nothing alike. The DEF was further asked how he didn't realize upon walking in the front door that this wasn't the right house, and the DEF didn't have an answer.

The DEF however did admit Post-Miranda to taking "half a shot of Fentanyl" this morning, and being 'out of it.'

The DEF's roommates were earlier spoken to, to include his boss who is staying in the same Air B&B. The DEF's boss advised LEO that right before this incident, he saw the DEF in the Air B&B's kitchen, and the DEF appeared to be 'out of it' and advised he was going to the Wawa nearby. The DEF then left the Air B&B and then this happened.

EMS was called reference the K9 apprehension and the DEF was taken to a local hospital for treatment. The DEF was identified via his FL DL. The DEF does not own the home and has zero rights to be inside of it.

Post-Miranda the DEF admitted to hearing the K9 officers announcements but stated he 'just froze-up.' A search incident to arrest revealed a small baggie of a controlled substance (later field tested positive to be methanmphetamine).
